The global SSE Forum **Bordeaux GSEF 2025**

In autumn 2025, the Global Social and Solidarity Economy Forum will be held for the first time in France, following editions in Seoul, Montreal, Bilbao, Mexico City and Dakar. This major biennial international event brings together all stakeholders in the Social and Solidarity Economy ecosystem.

The objective?

To share visions and practices that can make the SSE the «norm that will regulate the economy of tomorrow», giving priority to people and collective projects over capital and structuring an economy based on proximity and the long term.

This 7th edition will take place from 29 to 31 October 2025 in Bordeaux, whose mayor is also President of the GSEF. It is organized by the City of Bordeaux in conjunction with the Nouvelle-Aquitaine Region, the Gironde Department, Bordeaux Métropole and CRESS Nouvelle-Aquitaine, in close collaboration with the GSEF General Secretariat.

Each edition of the Global Forum on the SSE:

- pursues a political objective by bringing together elected officials and leaders from around the world, international experts, development agencies, networks and actors in the field who are committed to promoting this human-centred and environmentally friendly economy. A final declaration sets out the political commitments, which are translated into a roadmap for the next two years.
- promotes the exchange of experiences and expertise implemented on all continents. Successful innovations led by local governments and all actors involved in the SSE are highlighted through a dense and coconstructed programme.

Bordeaux GSEF 2025 is an important milestone on the path to achieving sustainable development goals. With five years to go until Agenda 2030, it must enable us to bring together civil society and local authorities to take action, challenge decision-makers and accelerate the transition.

This is all the more crucial given that the world today faces numerous threats: wars, authoritarian regimes, economic turmoil, social conflicts, ecological disasters, etc. We need to show that another world is possible and that it already exists.

The Scientific Committee is therefore proposing a rich programme based on a strong theme and opening the door to a variety of sub-themes, fuelled by contributions from around the world.

Beyond the exchange site, the Forum extends in time and space thanks to regional itineraries, as well as a cultural programme and the promotion of the SSE for everyone, both participants and the general public.

Open to the city, Bordeaux GSEF 2025 is an opportunity to highlight the SSE in what it is and what it can be, present in the daily lives of residents, in order to demonstrate its strengths in serving the common good. Bridges are also being built with conventional economic actors to spread the values of the SSE and raise awareness of its contributions to the regions.










The Forum Exhibition hall

In May 2023, the 6th GSEF World Forum on the SSE was held for the first time in Africa, in Dakar. This forum, which brought together more than 5,000 participants, was a decisive moment in the development and recognition of the SSE on the African continent. From the adoption by the African Union of a ten-year strategy for the SSE, to the adoption by African states of an institutional framework dedicated to the SSE or strategies in favor of the SSE, to the emergence of SSE ministries linking it to specific issues such as crafts, the informal sector, solidarity, microfinance, the fight against poverty, etc. These dynamics are promoting a stronger African presence in international SSE forums. 



Global organization of local governments and civil society networks for Social and Solidarity Economy



An international organization...

The GSEF (Global Forum for Social and Solidarity Economy) is an international organization of local governments and civil society networks committed to promoting the social and solidarity economy (SSE) as a means of achieving inclusive and sustainable local development.

Created in 2013, the GSEF stands apart from existing international SSE initiatives and networks. Its focus on the role of local governments is a clear affirmation of their crucial role in governance and in addressing the major challenges of the 21st century, whether climate change, social cohesion or inequality.

The GSEF is convinced that systemic change begins at the local level, based on a partnership between civil society and the public and private sectors, with the ambition that the SSE will scale up and become the norm for tomorrow's economy, integrating collective management of common goods.

The GSEF promotes various forms of the social and solidarity economy, including social enterprises, cooperatives, foundations, mutual societies, and self-help groups, which place people before profits.

In addition to its biennial forum on the SSE, which has become one of the largest international gatherings, the GSEF operates in five key areas:



Capacity building for local governments (coconstruction of SSE public policies)



Exchange of experiences and practices



Research and publications



Creation and support of local and national SSE networks



(I) International advocacy for the international recognition of the SSE

The GSEF has significant capacity for convergence, through its numerous partnerships and strengthened collaborations, as well as its capacity for action.

The GSEF cooperates with international networks, which are also members. This collective action makes it possible to join forces according to priorities in order to promote the SSE and, with it, a transformation of development models.

Through its advocacy work, the GSEF has contributed significantly to the international recognition of the SSE by the most multilateral institutions, culminating in the momentum of 2022-2023 with the OECD recommendation, the universal definition of the International Labour Conference (ILC), and the resolution of 18 April 2023 adopted by the United Nations General Assembly.

... with a local focus

In October 2021, the GSEF General Assembly selected Bordeaux as the location for its permanent secretariat, previously based in Seoul, South Korea.

The city's bid was supported by four partner local authorities: the City of Bordeaux, Bordeaux Métropole, the Department of Gironde and the Nouvelle-Aquitaine Region, in association with the Regional Chamber of Social and Solidarity Economy Nouvelle-Aquitaine (CRESS) representing actors and networks of actors.

The GSEF is chaired by Pierre Hurmic, Mayor of Bordeaux (deputy Bordeaux Métropole), with Stéphane Montuzet, President of CRESS NA, as co-chair. Since the establishment of continental co-chairs in 2021, the Nouvelle-Aguitaine Region has held this position for Europe (deputy Gironde Departmental Council).

An event: the Global SSE Forum

In 10 years, the GSEF has become a recognized global network, demonstrating its ability to mobilise a wide range of actors from all continents. This is particularly illustrated by the success of the last six editions of the GSEF Global Forums (Seoul, Montreal, Bilbao, Mexico City and Dakar). The organization of this major event is entrusted every two years to a host city by the GSEF. Bordeaux GSEF 2025 represents the 7thedition of the Global SSE Forum.



DakarGSEF2023

Dakar hosted the 2023 edition of the GSEF Global SSE Forum, co-organized by the City of Dakar, RACTES, the **GSEF** and the Senegalese Ministry of Microfinance and SSE. The event took place over six days, a first for GSEF Forum, preceded in this case by two pre-forums: the SSE youth pre-forum and the Femm'ESS pre-forum. The large number of participants demonstrated strong mobilization in Senegal and Africa. This edition concluded with the reading of the Dakar Declaration in the closing plenary session.
